

## DRIVER REQUIREMENTS

### DOCUMENTS:

The documents requested at Easygo (Üvez Turizm) offices during vehicle delivery, provided that at least one of them has a chip, are specified below along with driver's license restrictions:

- **ID Card**
- **Driver's License**
- **For Economy and Compact Class Vehicles:** A minimum of a 2-year driver's license is required.
- **For Medium Class Vehicles:** A minimum of a 3-year driver's license is required.
- **For SUV, Minibus, and Full-Size Type Vehicles:** A minimum of a 3-year driver's license is required.
- **For Premium, Upper, and Luxury Class Vehicles:** A minimum of a 5-year driver's license is required.

### DRIVER AGE

Easygo (Üvez Turizm) applies a minimum driver age restriction determined by vehicle segments during vehicle delivery. The minimum driver age limits are specified below:

- **For Economy and Compact Segment Vehicles:** At least 22 years old
- **For Medium Segment Vehicles:** At least 24 years old
- **For SUV, Minibus, and Full-Size Type Vehicles:** At least 25 years old
- **For Premium, Upper, and Luxury Class Vehicles:** At least 28 years old

### CREDIT CARD

During vehicle delivery at Easygo (Üvez Turizm) offices, it is mandatory to have one or two credit cards issued in the driver's name to cover the deposit amount. The number of credit cards you need to have with you according to the vehicle type you rent is specified below:

- **For Economy and Compact class vehicles:** Single credit card
- **For Upper class, Minibus, and SUV type vehicles:** Single credit card
- **For Premium and Luxury Class vehicles:** Two credit cards

### DEPOSIT

During vehicle delivery, Easygo (Üvez Turizm) applies a provision (pre-authorization) for a certain amount from the credit card—or cards—registered in the driver's own name. These amounts are specified below:

- **For Economy and Compact class vehicles:** 4,000 TL
- **For Medium class vehicles:** 4,500 TL
- **For SUV and Full-Size type vehicles:** 5,000 TL

- **For Premium, Minibus, Upper, and Luxury Class vehicles:** 7,000 TL

**Note:** For Premium and Luxury Class vehicles, at least 2 credit cards may be requested. A provision of 3,500 TL can be applied to each of these cards, totaling 7,000 TL.

### **Different Conditions:**

If a corporate credit card (Commercial card) is to be used by the driver, an approval letter on letterhead paper, a stamp featuring the company's trade name, and a physical (wet) signature are required. The person signing must be a company partner or a member of the board of directors. The signature circular of the signing person is required.

### **Release of Provision:**

Provisions are automatically removed within a maximum of 21 business days following the return of the vehicle to Easygo (Üvez Turizm) company officials after your journey.

## **MILEAGE LIMIT**

The detailed table of Easygo (Üvez Turizm) regarding the number of rental days and the applicable mileage (km) limit is below. In cases where the mileage limit is exceeded, action will be taken according to the vehicle group and the number of days. Mileage excess fees are the amounts that will be specified in the contract signed when receiving the vehicle.

## **FUEL**

Easygo (Üvez Turizm) delivers vehicles with a "return as received" fuel tank policy. If you return the fuel tank below the level you received it; the fuel fee between the fuel level specified in the vehicle delivery form and the returned fuel level, plus an additional 200 TL service fee, will be charged to the user.

## **CROSS-BORDER POLICY**

Vehicles are not allowed to cross the country borders.

## **INSURANCES AND GUARANTEES**

The vehicle you have rented is insured under the compulsory traffic insurance provided by the car rental company. You can review details such as insurance coverage and damage deductible, if any, from the rental

agreement delivered to you; if you wish, you can also obtain information from company officials during vehicle delivery.

In the event of a possible accident, it is important that the necessary documents (e.g., accident report, alcohol report, and third-party information) are prepared completely for the process to proceed smoothly. We would like to state that no action can be taken without these documents, and the repair process cannot be initiated solely based on the driver's declaration.

Our guests who want more security can get information about additional insurance packages through the rental company and easily choose the protection that best suits their needs.

## **IMPORTANT INFORMATION**

- When going to pick up the vehicle, a Findeks (credit score) inquiry will be made for the individual or company.
- In the event that the vehicle is returned earlier than the delivery date; the amount to be refunded does not cover the total rental period. The fee for the days the vehicle was used by the guest is deducted from the total rental fee, and the cost of the days the vehicle was not used is refunded. This cost is calculated over the car rental amount on the date in question, and depending on the number of days, the usage cost in early return may remain higher than the total rental cost.
- Rental conditions other than the titles specified above will be notified to you in a way to be presented for your signature by the Easygo (Üvez Turizm) representative during vehicle delivery. Please do not forget to read the document presented to you before receiving the vehicle.
- For guest reservations whose Findeks result is negative or whose Findeks inquiry cannot be performed, the approval of the supplier company (Easygo) is required for you to rent.
